1) Cooperation :-

2) Industrial visit and training:-

3) Extending the Expertize :-

The Second Party will extend and provide the expertise in its area by delivering guest lectures,

seminars or workshops help in organizing invited lectures in relation to curriculum as co-curricular aids to the First Party.

4) Placement of trained students :-

The second Party will activily engage to take placement initiatives for the trained students of the First Party as per in house requirement of the Second Party or other group industries wherever possible.

5) Provision of Technical Assistance:-

As is and when needed the Second Party may provide technical Assistance in accordance with its practicality and feasibility to the First Party.

This agreement will be valid until it is expressly terminated by either Party on mutually agreed terms.
