MEMORANDUM OF UNDERSTANDING (MOU)

This is an agreement between "Party-A", Hereinafter called – Nalanda Academy, Ichalkaranji and "Party-B", Hereinafter called Principal, Shri Venkatesh Mahavidyalaya, Ichalkaranji.

1) PURPOSE & SCOPE:

- Providing books & reading material.

4) (Party-B) RESPONSIBILITIES UNDER THIS MOU:

(Party-B) Shall undertake the following activities:

- Provide man power / available resources as per requirement.
- Provide need based expertise.
- Giving guidance
- Recommending the studnets for participation.

5) IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:

 The attempts will be made to provide necessary career guidance and counselling to the aspirants. The collaborative activities without any monitary gains will be arranged for the benefit of the students.

6) FUNDING:

This MOU does not include the reimbursement of funds between the two parties. This work is on Honorary basis.

7) EFFECTIVE DATE AND SIGNATURE:

The MOU shall be enforced by the signature of parties A and B as authorized officials. It shall be in force from 09/03/2020 to the date until either of parties terminates MOU. Parties A and B indicate agreement with this MOU by their signatures.
