#### Introduction:

The purpose of including a reservation policy in India's constitution was to achieve social justice, i.e., no discrimination based on backwardness and equal opportunity for all. In India, reservation is a system that gives scholarships, fee concessions, 65.5% - 75% seats in educational institutions, jobs, and test and age relaxation. Reservation was motivated by the desire for representation in school, employment, and politics.

- Since the establishment of the Institution recruitment is strictly based on the UGC guidelines & as per government norms. Permanent & temporary recruitments of teaching/non-teaching staff are done under government & university approval according to reservation policies. Print & online media such as advertisement in newspapers and its publication on web site are utilized in the procedure of recruitment.
- During the procedure of admission of the students the prospectus is published referring to rules and regulations. The merit list as per the reservation policy is prepared from the applications and displayed on the notice board as well as college website.

#### **Involvement**

As per the ref. letter of Shivaji University, Kolhapur, Special Cell 2021-2022/602, Dated 18<sup>th</sup> Feb.2022 prevention of Caste Based Discrimination in Higher Education reg. send by Shivaji University (Ref.
